### **Guidelines:**

1. Marching units must be able to keep pace at a brisk walking speed for the distance of the parade (approx 2 miles.) A decorated support vehicle (**for your group**) is suggested to provide refreshment or substitute marchers.
2. Motorized floats must be decorated with a variety of natural and/or artificial decorations in good taste and in the spirit of Christmas.
3. Flatbed floats with riders must be equipped with a guard rail or rope barrier not less than three feet from the bed around the circumference of the truck bed to prevent falls from the vehicle.
4. One MANDATORY pre-parade meeting attended by representatives of each parade unit is scheduled for Monday, December 12, 2022.. The participant will be given last minute information. Drivers of floats and other motorized entries must bring driver's license, proof of insurance and vehicle safety inspection.
5. There is no charge to participate in the parade, however, each parade unit is asked to bring a 10 pound bag of individually wrapped hard candy for Santa's sleigh. (Please no chocolate candy)
6. The deadline for submitting applications is **Monday, December 12, 2022 (at the mandatory participant's meeting)**
